# WISCONSIN ASSOCIATION OF FAMILY AND CONSUMER SCIENCES BOARD OF DIRECTORS MEETING January 17, 2015

The meeting of the WAFCS Board of Directors was convened by conference call at 9:03 a.m. by President, Jeanne Schwass-Long.

Agenda: The agenda was accepted as distributed.

<u>Secretary's Report:</u> Mary Kaye Merwin reported that the minutes of the October 25, 2014 Board of Directors Meeting had been read and approved by the two appointed readers. <u>Treasurer's Report:</u> Treasurer, Susan Turgeson reported that primary income activity to date is from member dues. Current assets for the association are \$29,870.82. The current assets for the WAFCS Foundation are \$78,520.36. It was reported that the Foundation Board is still searching for additional options for safe investment of a portion of their funds.

VP PROFESSIONAL DEVELOPMENT: Esther Fahm's report was received as submitted. She then deferred her time to the 2015 Conference Chairs.

2015 ANNUAL CONFERENCE REPORT: Conference co-chairs, Susan Turgeson and Karen Dickrell provided a committee update as well as a complete outline of the conference content. The co-chairs were thanked for their hard work and the exciting program. Registration materials are on the website and have been distributed. The report was received as submitted.

NEW PROFESSIONALS: Cathy Lader joined the meeting to report on her work in developing a new professional mentoring program called "Protégé Plus". This program is set up to include a coalition of FCS groups including UW-Stout, UW-Stevens Point, UWEX, FCCLA Foundation, DPI, WAFCS, and WAFCS Foundation. Since all board members had not received Cathy's report, it was suggested that action on moving this program forward occur at our March Council meeting. Cathy
